**RESOLUTION APPROVING EMERGENCY CONTRACT FOR
THE REPAIR OF CHESTNUT STREET WELL #3
IN THE BOROUGH OF CLAYTON NUNC PRO TUNC**

WHEREAS, Richard Middleton, Director of the Clayton Public Works Department has submitted Certification of Request for Emergency purchase; and

WHEREAS, it has been determined that said purchase and repair is an emergency condition; and

WHEREAS, Richard Middleton, Director of Public Works, has issued said request (attached hereto) indicating the reasons said emergency exists; and

WHEREAS, Richard Middleton, Director of Public Works, has obtained a quote from A.C. Schultz, Inc. to repair said emergency dated December 12, 2011; and

WHEREAS, the governing body is in agreement that said emergency contract must be awarded without public bidding pursuant to N.J.S.A. 40A:11-6.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey as follows:

1. That the governing body does hereby declare that an emergency exists with regards to the repair of Chestnut Street Well #3 in the Borough of Clayton and as certified to by Richard Middleton, Public Works Director.
2. That the governing body does hereby authorize the execution of a Contract between the Borough of Clayton and A.C. Schultz, Inc. for the repair of said Chestnut Street Well #3 per the estimate of \$9930.00 submitted to the Department of Public Works dated December 12, 2011.
