**RESOLUTION APPOINTING FRANCIS J. ORLANDO, JR., ESQUIRE AS
SPECIAL HEARING COUNSEL FOR A BOROUGH OF CLAYTON POLICE

WHEREAS, the Borough of Clayton had commenced a police disciplinary hearing matter; and

WHEREAS, it was determined that the Borough Solicitor, Timothy D. Scaffidi, Esquire, had a conflict which caused him to disqualify himself from serving as the Hearing Counsel to the Public Safety Committee as the Apparent Authority for the hearing; and

WHEREAS, a replacement Special Hearing Counsel is required to continue with the pending disciplinary matter; and

WHEREAS, Francis J. Orlando, Jr., Esquire of the firm Connell Foley has extensive experience in dealing with similar matters.






