

ORDINANCE # 15-2013

**AN ORDINANCE AMENDING CHAPTER 89, ARTICLE XIII, SCHEDULES,
SECTION 23 OF THE CODE OF THE BOROUGH OF CLAYTON
(VEHICLES AND TRAFFIC)**

BE IT ORDAINED by the Mayor and Council of the Borough of Clayton,
County of Gloucester and State of New Jersey as follows:

Section 1. Chapter 89, Section 23 is hereby amended by adding the following No Parking street location

Name of Street	Side	Location
Walnut Street	South	From the corner of Delsea Drive (State Route 47) to a point 132 feet west therefrom

Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 4. Severability

Each section of this Ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective, shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

Section 4. Effective Date

BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon formal approval by the Clayton Borough Council and publication as required by law.
