

RESOLUTION 114-13

**AWARDING CONTRACT FOR WIRELESS
(RF) AUTOMATICALLY READ WATER METERS WITH METER
COUPLINGS AND GASKETS**

WHEREAS, the Borough of Clayton desires to purchase up to Two Hundred (200) 5/8 inch by 3/4 inch T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets, and One Hundred (100) 5/8 x 5/8 T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets.

WHEREAS, RIO Supply, Inc., of Sicklerville, NJ has submitted the lowest responsible bid of \$59,987.00; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton, certifying that funding is available through an appropriation in the 2013 Water and Sewer Budget.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Clayton, County of Gloucester and State of New Jersey that a contract be and is hereby awarded to RIO Supply, Inc. of Sicklerville, NJ for the purchase up to Two Hundred (200) 5/8 inch by 3/4 inch T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets, and One Hundred (100) 5/8 x 5/8 T-10 Wireless (RF) Automatically Read Water Meters with Meter Couplings and Gaskets in the amount of \$59,987.00, pursuant to the specifications of the Borough of Clayton and the bid submitted.

BE IT FURTHER RESOLVED that the Water and Sewer Department is authorized to issue a purchase order/voucher to RIO Supply, Inc. of Sicklerville, NJ.
