

**RESOLUTION # R 167-13**

**RESOLUTION OF SUPPORT FOR BICYCLE LANES ON ROUTE 47/DELSEA DRIVE IN THE BOROUGH OF CLAYTON**

*WHEREAS*, the New Jersey Department of Transportation has informed the County of Gloucester that it wishes to establish bicycle lanes along a portion of Route 47 (Delsea Drive) between Clinton Street in the Borough of Clayton and the Clayton Borough-Glassboro corporate lines (approximate mileposts 59.64 to 60.93); and

*WHEREAS*, the Borough of Clayton supports the bicycle lanes on Route 47/Delsea Drive as follows:

**In the Borough of Clayton:**

**ROUTE 47 (DELSEA DRIVE)**

**NO STOPPING OR STANDING**

No person shall Stop or Stand a vehicle on any day (including public holidays) upon any of the streets or parts of streets described.

**BIKE LANES**

The lane locations described are hereby designated as Bicycle Lanes. No vehicle other than a bicycle shall be permitted the use of said lane.

<u>Name of Street</u>	<u>Side</u>	<u>Lane Width</u>	<u>Limits</u>
Route 47 Delsea Drive	Both	Entire Shoulder	Between Clinton Street and the Clayton Borough-Glassboro corporate line. (Approximate mileposts 59.64 to 60.93)

***NOW, THEREFORE, BE IT RESOLVED*** the Mayor and Council of the Borough of Clayton, County of Gloucester, and State of New Jersey that bicycle lanes on Route 47/Delsea Drive as proposed by the New Jersey Department of Transportation is hereby supported by the Borough.
