RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF FIRE DEPARTMENT TURN OUT GEAR

WHEREAS, there is a need to purchase Turn Out Gear for the Fire Department for the Borough of Clayton, County of Gloucester, State of New Jersey; and

WHEREAS, this can be purchased through State Contract #A80948 and #A80961, and

WHEREAS, the amount of the purchase price is \$15,876.00 for the Fire Department Turn Out Gear.

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton dated September 12, 2013 certifying that sufficient funds have been appropriated and are available to cover this contract. BE IT FURTHER RESOLVED that the Mayor and Clerk be and hereby are authorized to execute said Contract.
