**RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF TWO (2)  
MPH BEE III, KA-BAND DIRECTIONAL RADARS FOR THE POLICE  
DEPARTMENT**

WHEREAS, there is a need to purchase two (2) MPH BEE III, KA-BAND Directional Radars for the Borough of Clayton Police Department, County of Gloucester, State of New Jersey; and

WHEREAS, this can be purchased through State Contract #A82101; and

WHEREAS, the amount of the purchase price is \$4,434.00 for two (2) MPH BEE III, KA-BAND Directional Radars; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton dated September 12, 2013 certifying that sufficient funds have been appropriated and are available to cover this contract. The funds are available by virtue of an appropriation in Ordinance 2013-9; the original of said Certification is attached to the original of this Resolution and shall be filed in the office of the Borough Clerk of the Borough of Clayton; and

WHEREAS, public bids are not required when the purchase is under a state contract in accordance with 40A:11-12 of the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, that R & R Radar Inc., of Atco, NJ be and hereby is awarded the Contract for the purchase of two (2) MPH BEE III, KA-BAND Directional Radars for a total bid amount of \$4,434.00 and in accordance with and as more particularly described in the bid proposal submitted by said bidder and in accordance with the terms and conditions set forth in the specifications promulgated by the Borough of Clayton; and

BE IT FURTHER RESOLVED that the Mayor and Clerk be and hereby are authorized to execute said Contract.


