**RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF TWO (2)
2014 POLICE PATROL VEHICLES FOR THE CLAYTON POLICE
DEPARTMENT**

WHEREAS, there is a need to purchase two (2) 2014 Police Patrol Vehicles (Ford Interceptors) for the Borough of Clayton, County of Gloucester, State of New Jersey; and

WHEREAS, this can be purchased through State Contract #82925; and

WHEREAS, the amount of the purchase price is \$63,526.00 for the two (2) 2014 Police Patrol Vehicles, including Marked Police Interceptor package; and

WHEREAS, a Certification has been issued by the Chief Financial Officer of the Borough of Clayton dated July 11, 2013 certifying that sufficient funds have been appropriated and are available to cover this contract. The funds are available by virtue of an appropriation in the 2013 Municipal Budget Line Item – Police Car Lease; the original of said Certification is attached to the original of this Resolution and shall be filed in the office of the Borough Clerk of the Borough of Clayton; and

WHEREAS, public bids are not required when the purchase is under a state contract in accordance with 40A:11-12 of the Local Public Contracts Law.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Clayton, that Cherry Hill Winner Ford of Cherry Hill, New Jersey, be and hereby is awarded the Contract for the purchase of two (2) 2014 Police Patrol Vehicles (Ford Interceptors) and Marked Police Interceptor package for a total bid amount of \$63,526.00 and in accordance with and as more particularly described in the bid proposal submitted by said bidder and in accordance with the terms and conditions set forth in the specifications promulgated by the Borough of Clayton; and

BE IT FURTHER RESOLVED that the Mayor and Clerk be and hereby are authorized to execute said Contract.




